LFT SOFTWARE / THE CHAIN APP

Once you have received your username and password you will need to read through the LFT Company Compliance Manual and will be asked to sign off that you understand and accept the conditions within the manual.

Before you commence driving you will need to navigate via the menu bars to the Induction list and as a minimum complete all COMPULSORY INDUCTIONS and submit them into the LFT Chain App for approval.

These include the following:

- NTC Load Restraint (manual is available through The Chain App or our website) no certificate required to be uploaded as such but must confirm understanding of manual.
- Vic Roads Pre-Employment Medical check – no older than 3 years (or 1year for drivers over 50 years of age)
- Speed Management/Vic Roads Demerit point check – no older than 6 months
- Police check – no older than 2 years
- TLIF2010 – Driver Fatigue certificate (link to the online course via our website)

All certificates need to be uploaded into the Chain App for approval by LFT administration.

The above inductions are an absolute minimum but any driver wishing to increase and maximise their hours of work should also look at completing specific site inductions not limited to but highly recommending the following:

- Startrack
- VISY – site/COR/Driver
- Aldi

Please contact LFT administration to obtain the relevant passwords or vendor details to gain access to these site specific inductions.
