



Conditions of Entry to TIC Altona

☐ You must wear a safety vest / high visibility clothing and fully enclosed shoes
□ No children or pets are to exit the vehicle
☐ Observe the posted signs and the 10 km/hr speed limit
☐ Please refer to attached site Map which will direct you to your Destination and also provide direction on
how to exit the site.
☐ Wash room and toilets are available in Bay 3 and Bay 7.
□ Do not pass behind a forklift whilst the forklift is in the process of loading or unloading
☐ You must remain in the cabin or driver standing zone whilst the forklift is loading / unloading
your vehicle. Forklift drivers are instructed not to proceed unless you are in one of these 'safe zones'
☐ The forklift driver must remain parked and stationery when you attend to curtains and gates
☐ You are to follow the instructions of a TIC Forklift driver at all times. This ensures your safety and theirs.
☐ Smoking is only allowed in designated areas
☐ Do not enter the building through roller doors, use pedestrian doors and walkways only
☐ There is a new driver walkway at the rear of the facility next to the staff car park. DO NOT walk through
the container loading areas or the driveway to the Bay 7 Office. You will be reported.
☐ All incidents and accidents must be reported to a TIC Group Representative or Manager.
☐ You must have appropriate paperwork to either deliver or collect a load. No paperwork, no load!!!
☐ Ensure all curtains, doors and load is secure before departing
☐ In the event of an emergency evacuation, you must proceed with staff members on foot to the nearest
designated assembly area. No vehicles are to be in operation during an emergency evacuation or drill
